THE FINAL REPORT OF THE RETURNING OFFICER – ASM Elections 2017
ELECTION TO THE POST OF THE SCRUTINIZING COMMITTEE (2017-2018),

- 1) The 213th Annual General Meeting of the Asiatic Society of Mumbai was held in the Durbar Hall as per the Notice issued on 15th June, 2017. Nominations were invited from members to fill-in the following posts:
 - i) Scrutinizing Committee (7 posts) for one year (2017-2018)
 - ii) Office Bearers for two years (2017-2019) -
President (1 post)
Vice President (4 posts)
Hon. Secretary (1 post)
 - iii) Managing Committee (5 posts) for three years (2017-2020)
- 2) Details relating to the Nomination Process and Withdrawal of Nominations have already been displayed on the Society's Notice Board vide the Report of the Returning Officer dated 7th August and 10th August, 2017.

6) On 19-08-2017, at 3.00 PM, the empty Ballot Box was sealed in the presence of **Mr. Vivek V. Ganpule** and **Mr. S.S. Rege**, and the Returning Officer and the Asst. Returning Officer. After completion of the voting process, the ballot box was opened at 7.00 PM. and vote counting and scrutiny of ballot papers commenced thereafter.

7) **Adv. Devdatta Malshe acted as the Assistant Returning Officer.** As per Item No. 2 of the AGM agenda, (i) **Mr. Veerkumar S. Doshi**, (ii) **Mr. Vivek V. Ganpule**, and (iii) **Ms. Madhavi G.
