**1. Resident (Annual/Life) Membership:**

- a) The Resident Member shall be an individual who resides or has a place of business or service within the Mumbai Metropolitan Region.
- b) The Subscription for Resident (Annual) Membership is Rs.1, 500/- which has to be renewed every year in April. The subscription for Resident (Life) Membership is Rs.15,000/- which is for lifetime.
- c) Application Form charges : Rs 5/-
- d) An additional amount of Rs.235/- will have to be paid by a new entrant towards Entrance Fee (Rs.200/-, which is non refundable), a copy of Rules and Regulations of the Society (Rs.25/-) and for identity Card (Rs.10/-) A Resident ( Annual./Life ) member is entitled to borrow not more than 15 books ( 12old & 3 New) and 3 Periodicals at a time for a month.
- e) Two references from well-known person knowing the applicant by stating their 1) Name 2) Telephone No/Mob/No. 3) Email I.D.

**2. An individual applying for Resident (Annual/Life) Membership will have to attached the following documents (self attested) along with his/her application form:**

- i) A photocopy of residential proof: ii) A photocopy of the latest identity proof; iii) One stamp size photo for Library ID Card.

**3. Upon approval of the Membership Application by the Scrutinizing Committee, a letter will be sent by the Society's Office for making the necessary payment.**

**4. Rule 5(a) amended in AGM 2017: The Applicant for any Category of individual membership will be granted Provisional Membership of that category on production of self certified copy of Aadhaar Card/Indian Passport/Driving License by making payment of necessary subscription . The membership will be confirmed after approval by the Scrutinizing Committee. Till then, The 'Provisional Members' will be treated as a Daily Member without having to pay the fee per day. If the Scrutinizing Committee does not approve the applicant then he/she will cease to be a member and the amount will be refunded .**
