Terms of the Dr. Aroon Tikekar Memorial Fellowship:

1. The age of an applicant should not be less than 30 years and more than 65 years. The applicant must have a demonstrated or substantial body of work in his/her field of research/work.
2. The jury will consider each research proposal on its merits. The jury's decision will be final and binding on the applicant as well as The Asiatic Society of Mumbai. The applicant may be invited for a meeting if the jury so requires. In this case, the applicant will have to bear his/her own expenses.
3. This research cannot be a part of his/her doctoral thesis or any academic endeavour or any other research project in part or full, in the past. This research project may not be undertaken simultaneously with another research project in the same field or related field by the applicant.
4. If this work is included as a part of comprehensive or larger work in the future, due acknowledgement may be given to the Dr. Aroon Tikekar Fellowship.
5. This research may be undertaken in English or Marathi. If the dissertation is submitted in Marathi to the jury, it must be accompanied by a synopsis in English.
6. The project is expected to be completed and submitted on or before 31st December of the year in which it was awarded.
7. The total amount of the Fellowship for the year 2019 will be Rs. 1.25 lakh. A disbursement of Rs. 25,000/- will be made to the researcher at the start of the Fellowship. Thereafter, disbursement of Rs. 25,000/- will be made on May 31st and September 30th on submission of satisfactory interim status report of minimum 500 words. The final amount of Rs. 50,000/- will be given on submission of the research work and its approval by the jury. In the rare case of an extension being granted, additional remuneration will not be given.
8. If the researcher is unable to complete the project or the quality of the outcome does not satisfy the jury, the researcher should return the disbursed amount.
9. At the end of the project, the researcher will make a presentation to the jury and members of The Asiatic Society of Mumbai.
10. The copyright of the dissertation will be with the researcher. If the dissertation is accepted by the jury, the first right of publishing it will be with The Asiatic Society of Mumbai and due credit to Dr. Aroon Tikekar Centre for Advanced Studies should be given. If for any reason, The Asiatic
