- A3 Mr. S.G. Kale, Trustee of the Society, had asked for leave of absence.
- At the outset, the Officiating Hon. Secretary, Prof. Mangala Sirdeshpande, welcomed all the members to the Society's 218th AGM. She then requested the President, Prof. Vispi Balaporia, to take over the proceedings of the meeting.
- A5 The President took up the AGM Notice dated 18th August 2022 (218th AGM Regarding elections and postponement of Agenda Items) and informed the House that "As per the decisiono Managing Committee at its meeting held on 18th August 2022, only Agenda Item Nos. 2, 4and 5 (pertaining to the elections) will be taken up at the 218th AGM on Saturday, 27th August 2022 at 3.30 p.m. (The ballot boxes will be kept open from 3.45 p.m. to 6.00 p.m. or till all the members present have cast their votes, whichever is later) The remaining items will be taken up at the Adjourned AGM to be held on Saturday, 24th September 2022 at 3.30 p.m.
- B.2 She said that this decision had to be taken owing to unavoidable circumstances.
- B.3 The following resolution passed by the Managing Committee at its meeting held on 18th August 2022 was placed before the House:
- B.3-1 "Resolved that the Managing Committee shall have the 218th General Body Meeting on September 2022 for completion of the Agenda set out in the Notice dated 21st July 2022.
- B.3-2 Meanwhile, the Elections to the Scrutinizing Committee, to the post of the Hon. Secretary and the Managing Committee, may be held on 27th August 2022 as scheduled in the Notice of the AG Mdated 21st July 2022. However, the members of the new Scrutinizing Committee, Managing Committee and the Hon. Secretary will come into function with effect from 24th September 2022 when the declaration of results on the outcome of polling held on 27th August, 2022 which will be announced at the AGM i.e. the said day of the AGM i.e. Saturday, 24th September 2022."

- B.5 On 27th August 2022, the day of Election, on the basis of a resolution passed by a majority of votes by the members present therein in the General Body, Elections were held for the post of Managing Committee members for one year term (consecutive term 2022-2023 of the residual period 2020-2023) and three year term (2022-2025).
- B.6 Accordingly, the President requested the Returning Officer, Adv. A.V. Gopalakrishnan, to take up Agenda Item Nos. 2, 3, 4 and 5 of the 218th AGM Notice dated 21st July 2022, which pertains to the elections.
- B.7 However, as decided, the election results would be declared at the Adjourned meeting to be held on 24th September 2022.

- At the outset, the Officiating Hon. Secretary, Prof. Mangala Sirdeshpande, welcomed all the members to the Society's 218th AGM. She then requested the President, Prof. Vispi Balaporia, to take over the proceedings of the meeting.
- A5 The President, Prof. Vispi Balaporia, delivered the following Presidential address:

A5.1 PRESIDENT'S ADDRESS

As we entered the financial year 2021-2022, the clouds of another wave of Covid 19 with yet another lockdown were looming above us. Was this going to be a repeat of the previous year? Despite attempts to remain hopeful and positive, our worst fears proved right, and we had to bow to the decisions of the Government to once again go into lockdown mode. This time the period of inactivity proved shorter. The lockdown was lifted from 19 June, and we could begin to take stock of the situation afresh in order to move forward. However, the ability of the Corona virus to mutate kept the fears of the pandemic situation alive.

Unfortunately, our financial constraints continued. This had a serious impact on our projects, and reluctantly we continued to pay our staff only 65% of their salary, giving rise to non-cooperation from the staff. All in all, it was not a pleasant state of affairs. The Office Bearers and a few Managing Committee members rose to the occasion, and with their support I managed to hold the Society together.

The long months of closure we had experienced the previous year had trained us well in switching to the online mode in order to continue with meetings, lectures, talks, and other academic activities. As a result, we were able to pick up the pieces and cater to the needs of our members. I must appreciate the patience and understanding shown by our members during these difficult times. Hardships provide the best tests, and I can say with confidence that together we have passed this test. History has provided us many examples of such times, which Charles Dickens has brilliantly summed up: "It was the best of times, it was the worst of times, it was the age of wisdom, it was the age of foolishness, it was the season of Light, it was the season of Darkness, it was the spring of hope, it was the winter of despair."

2022 pulled us out of that "winter of despair". Some additional funds from the Ministry of Culture enabled us to begin paying our staff their 100% salary. With their cooperation we were able to hold the delayed elections in March, and your reconstituted Managing Committee is putting the pieces together again. I firmly believe that a happy staff makes for a well-managed institution, and, as each wave of Covid-19 recedes, the Society is coming together again.

The President then requested members to rise and observe a minute's silence in their memory. Though all these members would be missed, the President requested that she be permitted to make a few more remarks about Mr. C.G. Mane, who had joined the Society in 1996 and had been the A.O. for several years. In many ways, Mr. Mane had become the face of the Society. He had worked closely with most of the past Presidents and Hon. Secretaries. As current President and former Hon. Secretary, she had also relied a great deal on Mr. Mane's inputs and support. His sudden death was a real blow to the daily working of the Society, and a void that was difficult to fill.

A5.2 Agenda Item No. 1 was taken up.

B Item No. 1:

- B6 The President requested the Hon. Finance Secretary, Dr. Vishnu Kanhere, to respond to the queries raised by Mrs. Sushama V. Dabak vide her emails dated 22nd and 23rd September 2022 and also to the queries raised by Mr. Surendra Kulkarni.
- B7 Dr. Vishnu Kanhere, Hon. Finance Secretary, provided some clarifications, and assured that he would convey further clarifications to Mr. Kulkarni's satisfaction.
- B5 Thereafter, the minutes of the virtual meeting of the 217th Annual General Meeting held on Saturday, 22nd January 2022 (for the period 2020-2021) and the Adjourned Meeting held on Saturday, 12th March 2022 (for elections) were confirmed unanimously.
