## President's Message

As we entered the financial year 2021-2022, the clouds of another wave of Covid 19 with yet another lockdown were looming above us. Was this going to be a repeat of the previous year? Despite attempts to remain hopeful and positive, our worst fears proved right, and we had to bow to the decisions of the Government to once again go into lockdown mode. This time the period of inactivity proved shorter. The lockdown was lifted from 19 June, and we could begin to take stock of the situation afresh in order to move forward. However, the ability of the Corona virus to mutate kept the fears of the pandemic situation alive.

Unfortunately, our financial constraints continued. This had a serious impact on our projects, and reluctantly we continued to pay our staff only 65% of their salary, giving rise to non-cooperation from the staff. All in all, it was not a pleasant state of affairs. The Office Bearers and a few Managing Committee members rose to the occasion, and with their support I managed to hold the Society together.

The long months of closure we had experienced the previous year had trained us well in switching to the online mode in order to continue with meetings, lectures, talks, and other academic activities. As a result, we were able to pick up the pieces and cater to the needs of our members. I must appreciate the patience and understanding shown by our members during these difficult times. Hardships provide the best tests, and I can say with confidence that together we have passed this test. History has provided us many examples of such times, which Charles Dickens has brilliantly summed up: "It was the best of times, it was the worst of times, it was the age of wisdom, it was the age of foolishness, it was the season of Light, it was the season of Darkness, it was the spring of hope, it was the winter of despair."

2022 pulled us out of that "winter of despair". Some additional funds from the Ministry of Culture enabled us to begin paying our staff their 100% salary. With their cooperation we were able to hold the delayed elections in March, and your reconstituted Managing Committee is putting the pieces together again. I firmly believe that a happy staff makes for a well-managed institution, and, as each wave of Covid-19 recedes, the Society is coming together again.

## ANNUAL REPORT FOR THE YEAR 2021-2022

### 1. HIGHLIGHTS OF THE YEAR

The new financial year started with the grim situation of the Delta variant affecting the country and the consequent lockdown announced by Government of Maharashtra from 7th April 2021. It lasted till 21st June. Mr. Mane, the A.O. of the Asiatic Society, rose to the occasion and managed the affairs of the Society efficiently under difficult circumstances.

Due to the Society's consistent efforts in putting forth their financial difficulties to the Culture Ministry, the annual grant was restored to Rs. 1 crore in the new financial year. Immediately, the Managing Committee increased the salary of the staff from the previous 45% to 65%. It also paid in three installments the back wages of the remaining 55% due to the employees, arising out of a cut in their salary the previous year.

The Society renewed certifications such as 80G, 12A and 23C (IV) with the help of consultants. It had applied for and got the CSR number making it eligible to receive CSR funds. Under the guidance of Mr. E. Kshirsagar, the Chairman of the Board of Trustees, it adopted a new accounting policy as per the guidelines of the Indian Accounting Standards (as notified under section 133 of the Companies Act).

This year the Society purchased more mobile racks to store books. The committee got the electrical lines in the premises checked to avoid leakage and waste. In response to the audit findings, the wiring was changed in many rooms and new electrical fittings were fixed.

With a one-time grant from H.E. the Governor of Maharashtra's funds, fiber optic cable network was installed in the Society. This increased the network bandwidth, resulting in improved networking.

The Society undertook the restoration of statues. The CSMVS generously assigned the expertise of their best conservationist, Mr. Anupam Sah. He prepared a meticulously professional proposal which enabled us to attract donors. In this way, each of the ten statues was adopted, and the restoration team, under Mr. Anupam Sah's supervision, was able to complete the restoration.

### 1.1 EFFORTS TO GARNER FUNDS

The office bearers have been writing continuously to the Ministry of Culture for an increase in the annual grant. MOC had sent a query regarding the aims, objects of the Society, and how these were being fulfilled. In response, the Society had prepared a 99-page report on the various activities conducted in the last few years and forwarded it to the ministry.

Due to the efforts of Mr. S.G. Kale, the former President and now a Trustee, the Government of Maharashtra sanctioned Rs. 5 crores for the second phase of the digitization project from the financial year 2021-22.



Some of the Office bearers met with Shri Ashok Chavan, Hon. Minister of the Public Works Department, Government of Maharashtra, to request him to facilitate the infrastructural upgradation of the Society's premises.

The issue of financial crunch being faced by the Society was raised in Parliament by Parliamentarian Shri Arvind Sawant. The office bearers of the Society wrote to the Governor and a few others highlighting this issue. Similarly, a representation was made to the BMC Commissioner requesting enhancement of the annual grant. These efforts led to more queries from both the Centre and the State regarding the financial situation of the Society. Whatever information is sought, has been provided. The Society is awaiting a positive outcome.

## **1.2 VISITS OF SOME OF THE NOTABLE INDIVIDUALS DURING THE YEAR**

In October 2021, the Society, in collaboration with the Consulate of Italy and the Centre for European Studies of the University of Mumbai, organized a programme commemorating Dante titled A New Beginning focusing on Dante's 'The Divine Comedy'. H.E. Vincenzo De Luca, the ambassador of Italy to India delivered the keynote address in the presence of the Italian Consul General, Signor Alessandro de Masi. Prof. Antonio Bove delivered a talk on 'An insight into Dante Alighieri's profile'. The students of Italian from the Centre for European Studies read passages from Canto V of Inferno of the Divina Comedia in Italian as well as several Indian languages. Extracts from the 1940 Tamil translation of the Divine Comedy by Kaviyogi Suddhanda Bharatiyar were read out by a member familiar with the language.

On 26th November 2021, on the occasion of the Foundation Day of the Society, Phase II of the Library Digitization project was inaugurated by Shri Uday Samant, Hon. Minister of Higher and Technical Education.

Parliamentarian Shri Arvind Sawant, representing South Mumbai Constituency, visited the Society to enquire about the financial crisis faced by the Society and the distress faced by the employees.

## **1.3 AGM AND ELECTIONS**

The 217th AGM and Elections were scheduled to be held in the month of October, but had to be postponed due to the prevailing uncertainty. It was decided to hold the 217th AGM and Elections on 22nd January 2022. But due to the spread of the Omicron variant, it was decided to postpone holding elections, while an online AGM was held on the said date. The adjourned item of elections was eventually conducted on 12th March 2022 to elect the office bearers for two years (2021-23) which included the President, 4 Vice Presidents and the Hon. Secretary, and to elect 5 members of the Managing Committee for three years (2020-2023), and 5 Members of the Managing Committee for the current period of three years (2021-2024).

## **1.4 ACTIVITIES OF THE SOCIETY**

A full verification of coins was carried out in the month of February 2022 by Mr. Mahesh Kalra, noted Numismatist. A detailed and meticulously prepared report has been submitted by Mr. Mahesh Kalra, which includes suggestions for improvements. We record our appreciation of Mr. Kalra's efforts in completing the verification of coins in the possession of the Asiatic Society of Mumbai.

The Endowment Lectures Committee, the Mumbai Research Centre, and the Lit Club conducted many programmes which were well attended and appreciated. The MRC conducted lecture series, workshops, walks, Heritage study tours, talks, musical events, Jashn-e-Azaadi, a student festival, and collaborative courses with city colleges. The Endowment Lectures Committee organized seven talks by eminent persons. The Lit Club organized many online talks, poetry reading sessions, conversations with authors, and a book launch and discussion at the Durbar Hall.

This year, three students have registered for PhD through the Kane Research Institute. These students have completed the mandatory requirement of the Research Methodology Course and appeared for the written examination. The institute conducted a certificate course in Ancient Indian Culture. Professor Osmund Bopearachchi, Emeritus Director of Research, French National Centre for Scientific Research, Paris was the guest speaker for the Annual Kane Memorial Lecture. He spoke on "Study of Trade in the Indian Ocean through Self-Portraits of Traders, with particular reference to the Murals of Maharashtra".

## **1.5. AWARD**

The Zonta Club of Bombay III is an arm of Zonta International that works for Gender Equality and Empowerment of women and the girl child. Every year, the Zonta Club felicitates a woman who paves the way, challenging traditional practice with her inner potential, wisdom, and vision for the good of humanity. The Zonta Club of Bombay III decided to honour Mrs. VISPI BALAPORIA for being elected the first woman President of the more than two-century old Asiatic Society by awarding her the Woman of the Year Award for 2020.

Owing to the pandemic and frequent lockdowns, the award was presented in September 2021.

## **1.6 FULFILLING THE AIMS AND OBJECTS OF THE SOCIETY**

The Society had applied for a supplementary grant from the Ministry of Culture. In response, a Grant of Rs.40 lakhs was received in January 2022. This greatly helped in the purchase of a large number of books, subscription to many periodicals, renewal of annual maintenance for various equipment, and to the subscription of Koha, the library software, and Jstor, the digital library.

The Society was also able to restore 100% salary and applicable DA to the staff in the months of January, February and March 2022. In all, despite many challenges, the year ended on a happy note.

### **1.7 THE SOCIETY REGRETS THE PASSING AWAY OF THE FOLLOWING MEMBERS:**

Mr. Gerson Da Cunha, a Member of the Society since 2010, passed away on 07 January 2022 at the age of 92. He was involved in various activities till the very end and was preparing to attend a meeting when he took ill. Unfortunately, he could not be resuscitated. He started his working life as a journalist at Reuters and then at All India Radio. He then stepped into the advertising world, first with J Walter Thompson, and then Lintas. The entry into the advertising world was rather accidental, as he had majored in Biochemistry at St Xavier's College and was planning to go for further studies to Nottingham University in the UK. But the move to Lintas brought him in close contact with Alyque Padamsee, Shyam Benegal, and Uma Krupanidhi. And that is how he found his niche in theatre and his talent as an actor. Though theatre was not an earning proposition, they performed excellent plays, and got superb reviews, which resulted in Bombay becoming the crucible for English theatre. He was a leading citizen of Mumbai, and worked tirelessly for AGNI, a social welfare organization. Alas, all good things have to come to an end. As the Times of India headlines stated: Renaissance Man of Mumbai no more.

**Dr Soonu Jamshed Kapadia** passed away in Mumbai on 28 December 2021. She was a Life Member of the Society from 1978. A scholar and educationist, Soonu devoted her life to teaching and guiding both school and college students. She did her graduation from Elphinstone College, her post-graduation from Mumbai University, and later acquired a second M.A. degree from Boston College, USA. Except for a couple of years of teaching at Sydenham and Government Law College, she spent most of her years in government service at Elphinstone College, where she rose to become Head of the English Department; she was also acting Principal of the college for a brief period. After retiring from Elphinstone College, she joined the Cathedral and John Cannon School, where she continued to teach and delight students of the eleventh and twelfth standards, as well as coach students for the Advanced Placement programme. Soonu's doctoral thesis on the loss of faith in some Victorian writers is a massive, two volume scholarly work on a subject close to her heart: the place of religious faith in a world that seemed to be moving further away from the certainty and centrality of established belief.

Soonu's lectures were unforgettable, whether she lectured on the Victorians or the Elizabethans or the Metaphysical poets. To each she brought the same passion, enthusiasm, and deep scholarship. But Soonu's dedication to her subject and her students went far beyond the confines of the classroom. She gave unstintingly of herself to students who were underprivileged, or in unfortunate circumstances, tutoring them for hours at her own home. She brought the same qualities of loyalty and generosity of spirit to her friendships, which she treasured and nurtured over the years. Soonu was a rare and dear soul who will be missed by everyone whose lives she had touched.

### **3.1. Staff Welfare Committee Report**

The Society has a total strength of 30 staff members. There has been no increase in the strength of the staff for more than 10 years due to paucity of funds. The posts of Librarian and Dy. Librarian have yet to be filled.

The Staff Welfare Fund, established in 1996 with the aim of providing immediate monetary assistance to meet the financial needs of the employees, has disbursed an amount to the tune of Rs.1,32,520/- towards medical expenses, college admissions and house repairs.

### **3.2 Stocktaking:**

The stock-taking was begun in January 2020 but has not been completed due to the lockdown and the ongoing work of installing new mobile racks.

### **3.3 Library Digitization Project Phase II:**

The Government of Maharashtra has sanctioned Rs. 5 Crore for the second phase of the library digitization project. Due to the lockdown the work of digitization picked up speed only in the month of November 2021. It is an ongoing project.

### **3.4 Publications Committee Report:**

The Publications Committee oversees the publication of projects of the Asiatic Society of Mumbai. Many of these publications are funded by the Vimal Shah Endowment which was instituted in 2014.

### **3.5 Dr. Aroon Tikekar Centre for Advanced Studies:**

Despite the pandemic, Dr. Tikekar Centre for Advanced Studies carried on with its activities.

The annual function to award the Fellowship was held Online on 1st February 2022. The Jury Panel selected the project submitted by Prof. Dr. Mala Pandurang for the Sixth Dr. Aroon Tikekar Research Fellowship (2022) for her research project 'An exploration of literary representations of the Mumbai local suburban train commute as a metonymic of life in the city.'

Ms. Jai Vipra, Dr. Tikekar Research Fellow (2020-2021), submitted her dissertation and presented her observations.

On this occasion, the guest speaker for the programme was Prof. Dr. Irina Glushkova, Chief Research scholar, Center for Indian Studies, Institute of Oriental Studies of Russian Academy of Sciences, Moscow. She spoke on the topic "In search of lost company : Some blurred pages from the History of Photography in the Bombay Presidency". Her talk was well received by the audience.

Unfortunately, due to the pandemic, the Dr. Tikekar Annual College Lecture Series could not be held.

## 14. PRESERVATION & CONSERVATION

### A. Conservation Section:

The details of work carried out during the year are given below:

After the Covid-19 pandemic, the office reopened on 21st June 2021 when lockdown restrictions were eased by the Government.

The details of the work done in Conservation Laboratory during the period 21st June 2021 to 31st March 2022 is mentioned below.

85 books were conserved / tissue during the year.

Also, anti-termite treatment was done in all the sections of Library, Office as well as Durbar Hall as per the schedule. The ASM staff carried out the anti-termite treatment.

### B. Microfilming and Digitization Section:

During this year, 520 digitized books were checked for quality under the Library Digitization Project.

Several bundles of survey maps numbering around 3,500 were flattened and kept in a cupboard Shelf Slips were prepared for Miscellaneous manuscripts, Printed Pothis, and P L Deshpande Manuscripts.

Y. D. Phadke's cards were arranged title-wise.

80 Researchers / Scholars referred to the digitized / microfilmed material from the Special Collection Room for their research purpose, and 145 microfilm printouts/soft copies were given to the researchers on payment.

## 15. BINDERY SECTION

During the year under review, 1,638 books were fully bound in this section. This was apart from the routine work of stitching and pinning the newspapers, repairing books and files, pasting, packing, and parcelling.

## **16. FINANCES**

The Society is partially funded by the Government of India, Ministry of Culture. from whom It receives an annual Grant-in-aid

The Review Committee, appointed by the Ministry of Culture in 2014, noted that the collections housed in the ASM are a legacy that needs to be preserved and bequeathed to future generations. The services offered by the Asiatic Society of Mumbai thus constitute a public good and there is public responsibility in bearing the costs for its preservation and maintenance.

In order to put the finances of the Society on a stable footing, the Review Committee recommended that the Ministry of Culture, Government of India, and the State Government should give a Corpus Grant of Rs. 50 Crores (Rs. 30. crores by the Ministry of Culture, Government of India, and Rs. 20 crores by the Government of Maharashtra), so as to enable the Asiatic Society of Mumbai to receive a steady income in the form of interest on corpus on a long term basis, which would be adequate to meet the administrative expenses, as well as to undertake academic and research projects spread over a period of 3-5 years.

The Review Committee also recommended that the Asiatic Society of Mumbai be designated as an Institution of National Importance by the Ministry of Culture with full budgetary support. The committee noted the historic significance of the Society, its valuable treasures in terms of books, journals, coins, maps, and manuscripts, as well as the continuing research activities and emphasized on the need for substantial support from the Ministry of Culture, Government of India.

This year, apart from the annual grant of Rs. 1 crore, the Ministry of Culture had given a supplementary grant of Rs. 40 lakhs to the Socieity. The Government of Maharashtra had given Rs. 1 crore for digitization of books, journals, and manuscripts and the BMC had given Rs. 5 lakhs to the Society.
